Light-Duty Motor Vehicle Purchase or Lease Incentive Program

The Light-Duty Motor Vehicle Purchase or Lease Incentive Program (LDPLIP) provides rebate incentives statewide to persons who purchase or lease an eligible new light-duty motor vehicle powered by compressed natural gas (CNG), liquefied petroleum gas (LPG), or hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid)

*Deadline for applications: **January 7, 2021***

GRANT STATUS

Natural Gas (CNG or LPG) Rebates Remaining:	994
Hydrogen or Electric Rebates Remaining:	1,026

Regardless of the amount of funding available, the TCEQ may award no more than:

- 1,000 rebate grants for a combination of CNG and LPG vehicles, and
- 2,000 rebate grants for hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid) vehicles.

Seaport and Rail Yard Areas Emissions Reduction (SPRY) Program

The purpose of the Seaport and Rail Yard Areas Emissions Reduction (SPRY) Program is to provide financial incentives for the replacement of older drayage trucks and equipment operating at eligible seaports and Class I Rail Yards in areas of Texas designated as nonattainment under the Federal Clean Air Act.

The TCEQ has received a sufficient number of applications to award all available funding under the SPRY Program and suspends acceptance of applications effective 5:00 p.m., November 5, 2020. The TCEQ may remove the suspension should additional grant funds become available.

The Rebate Grants program is a simplified first-come, first-served grant program to upgrade or replace diesel heavy-duty vehicles and/or non-road equipment. **The TCEQ has received a sufficient number of applications to award all available funding under the Rebate Grants Program and suspends acceptance of applications effective 5:00 p.m., August 21, 2020. The TCEQ may remove the suspension should additional grant funds become available.**

Emissions Reduction Incentive Grants (ERIG) Program

The goal of the ERIG program is to provide grant funding opportunities to offset the cost of projects that reduce emissions of nitrogen oxide (NOx) from high-emitting mobile diesel sources in eligible counties. Any person who operates or plans to operate on-road heavy-duty vehicles, non-road equipment, or stationary engines primarily in one or more of the nonattainment areas or other eligible counties of the state is potentially eligible for a grant. For infrastructure projects, persons owning or operating the infrastructure in an eligible county may also be eligible for funding.
