- The first will focus on how you convert to alternative fuel technology doing these difficult economic times.
- The second will discuss propane basic and functionality.

It was also mentioned that more partnership is expected as the coalition reaches out to other leaders of different alternative fuels.

Virtual site visits will allow for local businesses to compile all their content and showcase what the region does.

Finally, a regional bus survey will be conducted to examine the need for funding opportunities specific to our region.

b) Ben Finley discussed with the Stakeholders the future contract with DOE, which identifies six sub-tasks that the Coalition needs to choose from as tasks in the year 2021. Currently, Staff is performing two of the tasks: Sub-task 3.2 - ushering alternative fuel projects through a grant funding program.; 3.4 – General Stakeholders Outreach.

Discussion continued surrounding needs for input of additional tasks the Stakeholders would like to accomplish. The other sub-tasks include:

- 3.1 Stake holder Listening sessions
- 3.3 Alternative Fuel Infrastructure Corridor planning
- 3.5 Technical Assistance and Fleet Coaching
- 3.6 Technical Training and Education (with hopes of resulting in job placements via internships)

ITEM 7. 2020 Annual Survey

a) The Stakeholders were informed that the Annual Survey will request information for major activities and accomplishments of both public and private sectors for 2020.

Staff has streamlined the survey to be more user friendly. Staff mentioned that a focus has been geared toward learning about new alternative fuel stations. Discussion continued with vehicle fueling inventory for all alternative fuel vehicles, with emphasis on electrical hybrid and plug in vehicles, and a need to understand what manufactures are doing to improve fuel economy. Discussion continued to truck stop electrification, idle reduction, and decreasing the need of foreign petroleum. It was mentioned that alternative fuels helps to improve American made options.

Staff discussed that the Annual Survey will begin to collect the information.in January. Normally, the due date is in February, but due to the pandemic, it is extended to March 15, 2021.

It is still important to report on 2020 activity, despite low activity due to the pandemic. Staff notified the stakeholders that they can utilize their last year information as a basis for this year's annual survey. Thus far, there has been 11 responses, mainly the entities that were have assisted in previous years.

Staff will host a webinar on the Annual Survey to explain the importance, and provide instructions on how to fill out the survey.
