# ITEM 2: Update on Natural Gas Issues and Activities – Heather Ball, Texas Natural Gas Vehicles Alliance

a) Heather Ball updated the members on the goal of American Energy Institute. They broaden their name to focus on all American energy sources. Discussion continued on upcoming lunch and learn webinar for fleet managers and policymakers. The meeting will focus on what the key issues are, how to contact local resources, and follow up with questions or concerns.

## ITEM 3: Department of Energy Grant Application: Repowering for Electric School Buses - Jessica Keithan, Texas Electric School Bus Project

- a) Jessica Keithan gave an update on the application to the Department of Energy sponsored by the Texas Electric School Bus Project, University of Houston, and the Houston-Galveston Clean Cities Coalition. They are coapplying with the Clean Cities Coalition to facilitate equitable transition to a zero-emission school bus fleet in Texas. Discussion continued with 95% of school buses in the United States run on diesel fuel. As well as exposure to diesel exhaust impairs cognitive development. Children are especially at risk.
- b) Many factors were discussed surrounding the benefits of electric school buses, such as: electric buses being environmentally safe; reduced operating cost; energy efficient; quiet operation; and health safety guarantee.
